1. The Republic of Croatia has received a Loan from the International Bank for Reconstruction and Development (The World Bank) toward the cost of the Justice Sector Support Project (JSSP), and it intends to apply part of the proceeds toward payments under the following contracts:
  - No. JSSP-CW-1 – „*Reconstruction and Extension of the Ground Floor, and Adaptation of the Existing Department Store Building for the needs of the Municipal Court in Split, Croatia*“

The JSSP Project Implementation Unit (JSSP PIU), on behalf of the Ministry of Justice of the Republic of Croatia, would like to alert the business community about this contract opportunity under the JSSP. JSSP PIU is currently preparing the bidding documents for the referenced contract. The bidding documents will be available immediately after the technical elements of the bidding documents are finalized, tentatively – in March-April 2012. As soon as the complete bidding documents could be made available, a Specific Procurement Notice (SPN) for the above referenced contract shall be published and it shall provide specific details about the procurement process.
