INVITATION FOR BIDS (IFB)

1. This Invitation for Bids (IFB) follows the General Procurement Notice (GPN) for this project that appeared in UNDB online on *11 May 2010*.
2. The *Republic of Croatia has received* a loan from the *International Bank for Reconstruction and Development* toward the cost of *Justice Sector Support Project*, and it intends to apply part of the proceeds of this loan to payments under the agreement(s) resulting from this IFB: *Supply of Servers, Server peripherals and System Software (G-07)*.
3. The *Project Implementation Unit of the Ministry of Justice* serves as the implementing agency for the project and now invites sealed bids from eligible Bidders for *the supply of Servers, Server peripherals and System Software*.

- Lot 1: Software

- Lot 2: Hardware and embedded software

The supply and installation period is *12 weeks from contract effectiveness*.

Bidders may submit bids for one or for the two lots. Evaluation will be conducted on a per lot basis and the contract will be awarded to the lowest evaluated substantially responsive bid for each lot.

4. Bidding will be conducted using the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, edition of *May 2004, revised October 1, 2006 and May 1, 2010*, and is open to all Bidders eligible as defined in these Guidelines, that meet the following minimum qualification criteria:

(i) Experience

During the past five (5) years, the Bidder must have completed two (2) successful contracts involving the supply and installation of Information Systems of similar functional/technical characteristics and of a comparable scale.

(ii) Technical capacity

The Bidder shall furnish documentary evidence to demonstrate that it will have technical capacity to provide the warranty services for offered Information Systems for 3 years.

The technical and experience qualifications of Subcontractors can count for the provision of the warranty services. If local capacity to provide warranty services is not in place at the time of bidding then the Bidder must include a credible plan for establishing such capacity by the time of Operational Acceptance of the System or any Subsystem.

(iii) Financial viability

a) The Bidder shall demonstrate average annual turnover during the **last 3 years** of:

- Lot 1: at least USD 200.000 (two hundred thousand US Dollars) equivalent.
- Lot 2: at least USD 400.000 (four hundred thousand US Dollars) equivalent.

b) The Bidder shall be properly established in its country of origin, the Bidder and management staff of the company shall have not been sentenced for commercial crime(s), the Bidders shall have stable financial position and shall have fulfilled its obligations as to payment of taxes and duties in the country of incorporation.

(iv) Manufacturer's experience

The manufacturer of the Information Systems offered shall be certified for compliance with ISO 9001 or equivalent standards for quality management.

5. Interested eligible Bidders may obtain further information from **Project Implementation Unit of the Ministry of Justice** and inspect the bidding documents at the address given below from **09:00 to 16:00 hours on the normal business days**.
6. A complete set of bidding documents in **English** may be purchased by interested Bidders on submission of a written application to the address below and upon payment of a nonrefundable fee of **HRK 730,00 (Croatian Kuna seven hundred thirty)** or **EUR 100,00 (Euro one hundred)**. The method of payment will be wire transfer to the following bank account:

The document will be sent by **courier mail or may be collected by Bidder's representative from PIU office at the address below**. For the convenience of Bidders an unofficial electronic copy of the Bidding Documents in **MS Word format** may also be forwarded by **electronic mail**.
7. Bids must be delivered to the address below at or before **12.00 hours local time on 26 May 2011**. Bids **need** to be secured by a **Bid Security**. The amount of Bid Security required is: **Lot 1 - HRK 4.000 (Croatian Kuna four thousand) / Lot 2 - HRK 10.000 (Croatian Kuna ten thousand)** or an equivalent in a freely convertible currency. Late

bids will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below *immediately after the deadline for bid submission*.

8. The attention of prospective Bidders is drawn to (i) the fact that they will be required to certify in their bids that all software is either covered by a valid license or was produced by the Bidder and (ii) that violations are considered fraud, which can result in ineligibility to be awarded World Bank-financed contracts.
